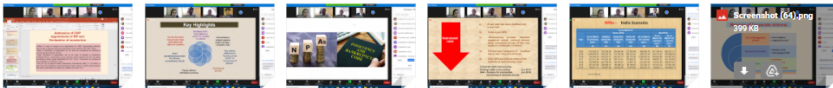

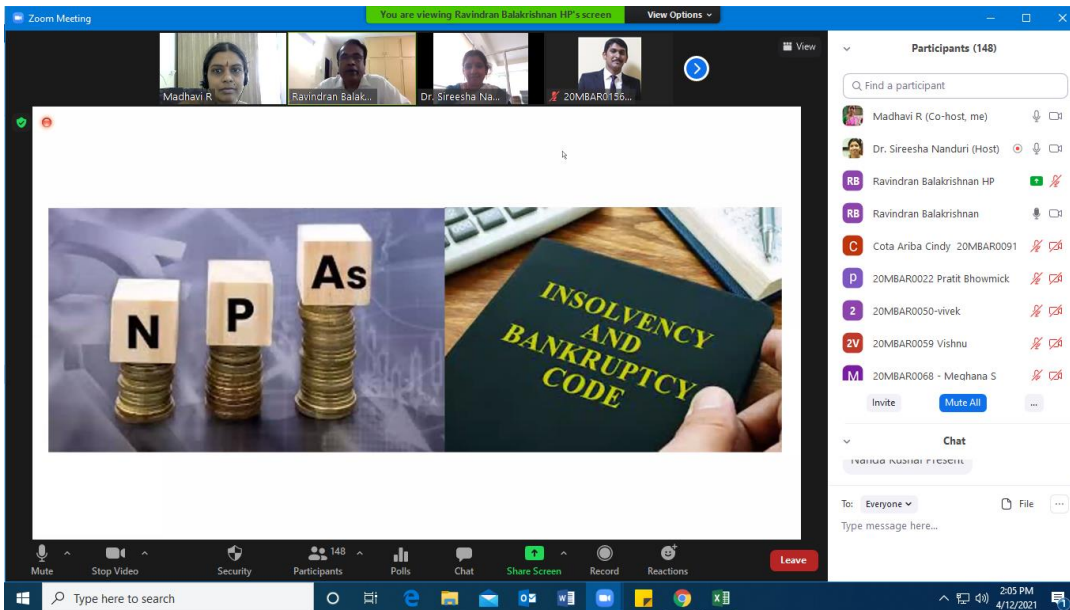


Figure 1.FIG Activity-NPA- 12-4-21-online -Batch 2020-22. sem-II-IFS
